PETITION OF THE UAE INTERVENTION GROUP TO INTERVENE

In accordance with Rule 756-100-6 of the Public Service Commission's Rules of Practice and Procedure and the Provisions at Utah Code Ann. § 63-46b-9, Con Agra Beef Company, Hexcel Corporation, IHC Hospitals, Thiokol Corporation, The Utah Association of Energy Users, and Western Electrochemical Company, (hereinafter and throughout the course of this proceeding referred to as the "Utah Association of Energy Users Intervention Group" or "UAE Intervention Group"), hereby move the Public Service Commission ("Commission") for leave to intervene in the above-referenced proceeding.

In support of this Petition to Intervene, the UAE Intervention Group states as follows:

1. PacifiCorp (“PacifiCorp”) has filed an Emergency Motion for Interim Rate Relief with the Commission.
2. The UAE Intervention Group are a group of customers who take service from PacifiCorp under Rate Schedules 6 and 9 or under Special Contracts.
3. The UAE Intervention Group have a direct, immediate and substantial interest in this proceeding as customers of PacifiCorp because the availability of electrical power, the rate they pay for electric service, and their willingness and/or ability to continue service arrangements with PacifiCorp may be affected by a decision of the Commission on PacifiCorp’s Application.
4. The interest of the UAE Intervention Group will not be adequately represented by any other party to this proceeding.
5. If the UAE Intervention Group is granted intervention, they hereby request that service of all pleadings, notices, etc. be made to the following:
