On October 6, 2014, PacifiCorp, dba Rocky Mountain Power (“PacifiCorp”) filed a settlement stipulation in this docket signed by all of the intervening parties (“Stipulation”). The Stipulation recommends the Public Service Commission of Utah (“Commission”) approve the Stipulation and all of its terms and conditions.
