

Change terms of agreement due to breach

The Original Payment Acceptance Arrangement is now being reinstated with the following additions, any and all presentment, Bill of exchanges, money orders, checks, letters of credit, bills of credit, negotiable instruments, and or payments of any type are to be credited to this account upon receipt without delay (within 12 hours of receipt of such presentments) and the trustees/fiduciaries are at no time permitted and/or allowed to change the terms of the agreement henceforth, heretofore and/or forever. The credits are to be applied to the account of the administrator, and access to such credits by the Administrator/Beneficiary are To Be Made immediately available upon receipt of any presentment presented to the trustees/fiduciaries within 12 hours of receipt of the presentment.

The trustees/fiduciaries are never to communicate with the administrator in any language other than modern English, are always to act in good faith and in the interest of the Administrator/Beneficiary as set forth in this presentment. The trustees/fiduciaries are not permitted to make any changes or alterations to the agreement henceforth/heretofore/forever.
