Mr. Kopta and Ms. Clauson and all,

Based on emails from yesterday afternoon, it sounds like we need not move the Scheduling Conference in Docket No. 07-2263-03 from its currently scheduled time of 0930 on 7 August.

With respect to the procedural conference in Docket No. 07-049-30, Eschelon is in hearings 14-16 Aug. Mr. Kopta suggests 17 Aug but I'm not available that day. That means either 13 Aug or the week of 20 Aug. That week is wide open for me. I guess my concern is an uncertainty as to what might need to be resolved at the procedural conference--are we looking to reschedule the hearing currently set to begin on 10 Sep? Are we looking to change deadlines leading up to hearing. I have scheduled a procedural conference because the parties requested a possible change to schedule based on Commission approval of the Settlement Agreement in 06-049-40 and agreement to permit a single compliance filing of the ICA following conclusion of the current arbitration. I'm happy to discuss process and schedule, but it seems to me, absent other concerns of which I am not aware, we could simply proceed in 07-2263-03 as scheduled and with hearing on 10 Sep.

Those are my thoughts at any rate. I'm happy to meet with parties on procedural matters sometime the week of 20 Aug. Just let me know what date works for your schedules. If 20 Aug is too late for some reason, it appears that 13 Aug is our only alternative.

Please let me know and I will issue a new notice accordingly.
