### BACKGROUND

On February 25, 2009, in Docket No. 08-2500-01, the Public Service Commission of Utah (PSC) granted TeleQuality Communications, Inc. ("TQ Inc.") a Certificate of Public Convenience and Necessity (CPCN), authorizing the company to provide public telecommunications services within the State of Utah. By Order issued December 7, 2017, in Docket No. 17-2500-01, the PSC approved the transfer of indirect control of TQ Inc. from its parent company, TQCI Holdco, Inc. to Education Networks of America, Inc. ("ENA"). On January 2, 2018, ENA purchased TQ Inc., making it a wholly-owned subsidiary of ENA. As part of the transaction, TQ Inc. became a limited liability company based in Delaware - TeleQuality Communications, LLC ("TeleQuality").

On March 24, 2020, ENA filed a letter with the PSC indicating TeleQuality will be changing its name to ENA Healthcare Services, LLC ("ENA HS") which it states became effective in Utah February 18, 2020. ENA included a certified copy of the name change amendment filed with the State of Utah Department of Commerce in its notification to the PSC.

On March 25, 2020, the Division of Public Utilities filed a memorandum recommending the PSC acknowledge the name change and make the necessary changes and amendments to all required documents. No other party filed comments.

If the PSC fails to grant a request for review or rehearing within 20 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the PSC's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
